The **Sioux City Public Museum Education/Exhibit Endowment Fund** is designed to give you access to the most favorable tax advantages available as well as help us develop planned giving programs.

### How it works

- The Sioux City Public Museum Education/Exhibit Endowment Fund was established within the Siouxland Community Foundation in 2007.
- Any donor can add to the fund at any time.
- Siouxland Community Foundation handles all the administrative details - including investment management - so that we can focus on putting our mission into action.
- Gifts made to the Sioux City Public Museum Education/Exhibit Endowment Fund are invested over time. Your gift - and all future earnings from your gift - provides a permanent source of support for the Museum, helping us to do good work forever.
- Iowa residents are eligible for the Endow Iowa tax credit. Donors may receive a **25%** tax credit for each donation. The tax credit is in addition to any federal tax benefits you may qualify for.
